

- Peer review for highest research quality
- Researchers on subject advisory boards, councils and committees




## HEI revenues for research and third cycle education



## Sweden's R&D in international comparison


The size of the circles illustrates the gross domestic expenditure on R&D as a percentage of GDP in 2017 in each country, in absolute numbers.


# Distribution of forms of grants 2019

Larger infrastructures, SEK 1 862 million





## News from VR

Covid-19-situation:

- continued home office for most, no travel or visits, prel until March 2021
- follow-up of digital BG meetings shows that it has worked beyond expectations

Infrastructure-calls for funding 2021 (see vr.se)

- a "regular" for 32 areas, open 2/12 16/2
- possibly one for investments, open 13/1 16/2

The needs inventory is planned for autumn 2021

VR:s appropriations increase by approximately SEK 1 billion in 2021 (budget bill)

- including a large addition to infrastructure
- research bill ~10th December
